

Migrant Farmworker Scholarship: Jean DeGrace Crandall Memorial Scholarship 2020

Community Foundations of the Hudson Valley - Scholarship Program

Scholarship Summary

Only apply to this scholarship if you are a a migrant farmworker or child of a migrant farmworker.

This scholarship was set up as a memorial to Jean DeGrace Crandall, educator and friend to the migrant community. She worked as a Tutor Advocate for the Mid-Hudson Migrant Education Outreach Program, a folklorist for the Dutchess County Arts Council and was the owner/operator of La Mula Chula in Rhinebeck, a store featuring fair-trade Mexican folk art, which she imported herself. An annual scholarship will be awarded for post-secondary assistance to a ***migrant farmworker or child of a migrant farmworker (with a preference for those from Mexico) with a history of migration to Dutchess, Orange, Putnam, Rockland, Sullivan, Ulster or Westchester Counties, New York.***

Eligibility Requirements:

- Migrant farmworker or child of a migrant farmworker with a history of migration to Dutchess, Orange, Putnam, Rockland, Sullivan, Ulster, or Westchester Counties
- Pursuing post-secondary education

Type of Award:

- Renewable-students must apply each year to be considered
- Awards will be paid directly to the qualifying post-secondary institution on behalf of the award recipient.
- Payments cannot be made directly to individual award recipients.

Application Details:

With your completed Online Application you will also need to attach the following:

- Most recent transcript
- 2 letters of recommendation from an employer, teacher, clergy or persons other than family members who are familiar with your skills and abilities. These letters must have been written within the last 6 months.

- An essay of 250-300 words describing a situation or obstacle you faced, how you dealt with it, and what you learned from the experience. How might that experience help others facing similar circumstances?
- **PROOF OF MIGRANT EDUCATION ELIGIBILITY:** Attach a copy of a 'Certificate of Eligibility' (COE) showing qualifications as a migrant student during the past 3 calendar years or any time during high school.
