Advocacy	44	S	C + H	Services with or on behalf of students, (including parents/family members, teachers, service agencies, and others) designed to ensure that migrant children and families receive the full range of services available to them; includes but is not limited to: • school-home linkage • regular education program linkage • health / dental / social service linkage • interstate linkageinterpretation/translation • High School Equivalency linkage • Goal setting • Review of transcripts
Attempted/No Service	71			<i>Service Provider</i> attempted to provide services to student but <i>Service Provider</i> was not able to provide such service. Example: <i>Service Provider</i> visited the student to provide ENL instruction but no one was home.
Counseling Services	30	S	C + H	Services to help a student to better identify and enhance his or her educational, personal, or occupational potential; relate his or her abilities, emotions, and aptitudes to educational and career opportunities; utilize his or her abilities in formulating realistic plans; and achieve satisfying personal and social development. These activities take place between one or more counselors and one or more students as consulees, between students and students, and between counselors and other staff members. The services can also help the child address life problems or personal crisis that result from the culture of migrancy. (definition from Consolidated State Performance Report (CSPR) guidance). NOTE: This supplemental service code only applies when these services are provided by a Certified Counselor who is employed by the METS.
ENL	1	I	C + H	Services to develop listening, speaking, reading, and writing skills in English as a New Language
English Language Arts	24	I	C + H	Services that support listening, speaking, reading, and writing skills

Enrichment Activity	74	S	C + H	Services/support for students that include, culturally responsive: •identity development activities, community service, and/or educational field trips; •career related activities coordinated by local/statewide MEP that provide students opportunities to explore and/or visit job sites, tour colleges/universities and vocational programs and meet with role models. NOTE: Any instructional component provided during an enrichment activity should be recorded separately with its instructional code. Sample scenario: Students participated on a State Park visit where a lesson was provided. If there is a lesson about habitats and water cycle for the first 30 minutes of the enrichment activity, you will record it as following: Enrichment Activity (C=1 H=4) and Science (C=1 H=0.5)
Life Skills	48	I	C + H	Instructional services to assist students in acquiring skills to meet the challenges of daily living including (but not limited to) health education

What are services? Services are a subset of all allowable activities that the MEP can provide through its programs and projects. “Services” are those educational or educationally related activities that:

- directly benefit a migrant child;
- address a need of a migrant child consistent with the State’s comprehensive needs assessment and service delivery plan;
- are grounded in scientifically based research or, in the case of support services, are generally accepted practices; and
- are designed to enable the program to meet its measurable outcomes and contribute to the achievement of the State’s performance targets.

What are allowable activities that are not services?

Examples of allowable activities that are not services are activities related to:

- Parental involvement
- Administration of the programs
- Handing out leaflets to migratory families on available reading programs as part of an effort to increase the reading skills of migratory children

Although these are allowable activities, they are not services because they do not meet all of the criteria above.
