

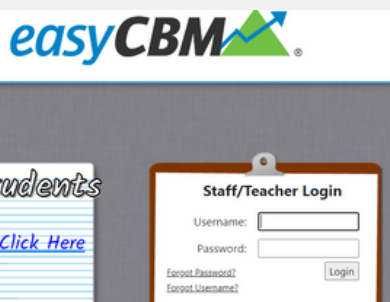

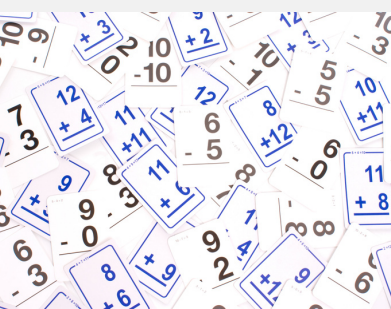

NYS-MEP Assessments: Important Reminders

If you haven't administered the assessments before, it's important that you learn how. Use the resources in this handout and coordinate with your director. Keep in mind that the ECA and BOLST have changes for 2025-26. Please note:

- The easyCBM fall benchmark window is 08/7/25-10/24/25.
- ECA & BOLST: As instruction starts in the fall, early on, administer the pre-tests to collect baseline data.

Directors: Schedule individual or group PD for easyCBM (Reading & Math) and the QPS, ECA, and BOLST.
