



- + Not all English language learners are migrant students

- + Not all migrant students AND not all English language learners speak Spanish


- Advocate for my students and families





...free, public education in the district that they live. No matter: citizenship, immigration status, language




...a qualified interpreter/translator in the language of their choice



...bilingual education programs for their children when there are 20 or more ELL students who speak the same language in one grade level

...meet with school staff at least once a year to discuss overall learning and language development progress.



...enroll their child in school without being asked anything about immigration.

NO: social security numbers, visas, citizenship documents






...receive information about their child's English language development



...an orientation session from the school in their language.



...to get support services that are available to all students, for their child.

Academic Intervention Services



...have their children placed in a bilingual education or English as a new language program within 10 days of enrollment



...their child receiving all core classes at the same academic level as all other students.

ELA/Reading Math Science Social Studies



...equal access for their child to all programming and services offered by the school district for their child's age level.




...to full access for their child to extracurricular activities.


Afterschool clubs Sports Etc.



...written notice in English AND their language that their child is an English language learner (ELL) and placed in an ELL program



...to have their child continue in an ENL program while they are still ELLs



...to yearly testing of their child to determine language progress and receive information about their child's performance on state tests.
