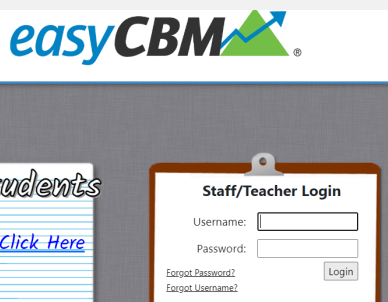

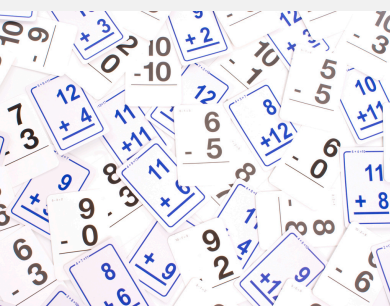

NYS-MEP Assessments: *Important Reminders*

Consider all staff members; do not assume they know how to administer the various MEP assessments. If they have not administered, they need to be taught how to do it.

Schedule individual or group PD for easyCBM (Reading & Math) and the QPS, ECA, and BOLST.

- easyCBM Fall Benchmark Window: 08/7/24-10/13/24
- ECA & BOLST: As instruction starts in the fall, early on, administer the pre-tests to collect baseline data.

Have staff administer the tests.
